

## **PRESS RELEASE**

## EXPOSING THE FRAUDULENT SCHEME BY MR. AKASH KALRA

Preceptors' IT and Business Solutions Private Limited is issuing this press release to inform the public about a fraudulent scheme orchestrated by Mr. Akash Kalra. Our company has diligently investigated this matter since March 2023 and wishes to bring to light the disturbing details of this scam.

Akash Kalra joined our company in February 2022 in the capacity of a Business Manager, where he made assurances of bringing multiple clients to our BPO division. Within just two weeks of his tenure, he proposed non-voice projects with FedEx and Singapore Airlines. Unfortunately, due to unforeseen circumstances, these proposals did not progress.

Approximately two months later, Akash Kalra approached us with an offer to become an outsourcing partner for the previously mentioned campaigns. He claimed to have a friend with authorization to onboard centers for these processes. However, our company declined this proposal as well.

In July of the same year, Preceptors' IT and Business Solutions Private Limited established a subsidiary named Spectics, whose sole objective was to foster new startups by bringing them under our wing. It came to our attention that Akash Kalra had independently begun outsourcing the campaigns that we had previously rejected, under the name of Spectics Consulting, even going to the extent of forging signatures and company's seal.



By September 2022, we had engaged with two firms that had made payments for these processes, but no work had commenced. Sensing irregularities, we suspended Akash Kalra from his position in September 2022 until February 2023.

From February 2023 onwards, it became evident that Mr. Akash Kalra's behavior had become increasingly erratic. He was found to be forging our company's letterheads and fabricating fake Memorandums of Understanding (MoUs) with the intent to deceive various BPO centers into releasing fund amounting to anywhere from INR 35000 to INR 230000. Notably, he conspired with an individual named Gregory Candela in an attempt to frame him for his fraudulent actions.

As of the latest information available to us, Mr. Akash Kalra's current whereabouts are known to be in Chandigarh, where he is reportedly working at Cloudpoint Technologies Private Limited. It has come to our attention that he forged a fake letter of experience from Preceptors' IT and Business Solutions Private Limited to secure this position.

It has also come to our attention that Akash Kalra's spouse Ms. Vinita Kochhar, is also implicated in this scheme, both being associated with a firm known as Maanya Infotech.

We would like to caution the public and fellow businesses to exercise due diligence while entering into partnerships or transactions
